1. Virements

4. Recreation Ground Lease

The outline terms were discussed. These will be reflected in a draft lease. ACTION: KR/DT

5. Additional Bank

Although less urgent due to the level of payments (mainly to do with the Playground Equipment Refurbishment) it was agreed that another bank should still be researched; however not urgent. ACTION: KR/DT

6. IT Support

KR updated the meeting on progress with setting up the Councillors on Outlook 365. Two have required support from the help desk but all are now up and running, with one exception. (Now resolved).

The Parish Council Tax paid by the average resident in Salehurst & Robertsbridge increased from last year (2022-23) by **8.68**%. This is due to various factors:-

- 1. Increase of total expenditure in the Parish's budget of **8.98**%. This is due to the salary increases of 9.37% and by the increase of other costs of 18.47%.
- 2. An increase in Other Income (mainly cemetery income) by **20.4**% reduces the Net Expenditure that has to be funded by the Precept.
- 3. This means that the Precept increased by **8.48**%.
- 4. However, because the tax base (see Note) has reduced, the Parish Council Tax increased by **8.68**%.

[**Note**: the "tax base" is the level of council tax that RDC expects to be able to recover from residents. This varies because of:

- a) the number of residents claiming support through the Council Tax Reduction Scheme ; and
- b) the collection rate.]
