BECOMING A PARISH COUNCILLOR: next steps...

Hopefully everyone is aware by now that in May all nine Parish Council seats are up for election/re-election, and several of the current councillors will not be seeking re-election. If you are considering standing for election yourself, this should clarify the steps you need to take. The Nomination period for applications **opens on 30th March 2015**, and from this date the nomination pack (with forms) will be available from either the Parish Office or Rother District Council. These are *different* packs from the information pack you might already have picked up! You will also need a proposer and a seconder (who must be registered to vote in this Parish).

The Nomination period is very brief - it closes strictly at 4pm on Thursday 9th April 2015. Your *valid* application needs to be submitted, preferably by hand, at the Town Hall in Bexhill by this deadline. So, allow time for any errors and omissions to be dealt with. Also, be aware that your electoral roll *number* (and those of your proposer and seconder) will be required; you can obtain these from the Parish Office or Rother District Council.

If nine or less nominations are received, all will be 'elected unopposed'; if more than nine are received there will be a poll, on 7th May (alongside the Rother District Council and General Elections). The new council will come into effect on 11th May.

Good luck, and we hope to welcome some new faces!

A WORD ABOUT STREETLIGHTS...

If you spot a streetlight in the village not working correctly, then the Parish Council is the appropriate place to report it to, on 882066 or email clerk@salehurst-pc.org.uk. Those on the 'main arteries' - George Hill through to the roundabout, and Station Rd, are generally on from dusk to dawn, but others turn off at midnight.

When one becomes stuck on during the day, it does not run up our electricity bill, as this is *unmetered* for streetlights. However, of course we wish to prevent energy waste promptly. Page 2 Volume 8 Issue 4

But this can often delay the matter reaching the right people, as the Parish Council office is only staffed part-time.

NEIGHBOURHOOD PLAN update...

In the last Parish Council Newsletter you read about the exciting plans the Parish Council had to create our own Neighbourhood Plan; to have a shared vision for the future of our community, to have a say about where new homes should be built, what type they would be and what they would look like, to safeguard our treasured assets and green spaces, and to influence all types of development within our parish.

At the first public event, in the Youth Centre on 10th January, many of you turned up to hear from experts what our own Neighbourhood Plan could do for us. The big consultation process, so essential to the production of a sound Plan, started there with people's ideas going onto the big maps we had set out. Several people said they were willing to help in the task of driving the Plan forward, and they were contacted and have now met several times under the auspices of the Parish Council to start the process. We now have Terms of Reference, which are

essential to show good governance and Stephen Hardy was elected to chair the Steering Group.

From the 10th January event it was clear that several themes emerged from all the public comments. The Steering Group decided to divide up the work into these strands, a course followed by most of the thousand-plus parishes in England who have done or are doing their own Neighbourhood Plans. Our themes, together with their leaders are listed in the table below.

If you would like to get involved and one of these areas particularly interests you, please get in touch with the leader, who will be very glad to hear from you.

The formal application to RDC to designate the parish as a Neighbourhood Plan Area is now in the 6-week consultation period. See Rother District Council's website www.rother.gov.uk.

Our stall at the Annual Village Meeting in March gathered further ideas from the community about making the village better - parking problems, especially, were a concern.

Please look out for the major questionnaire we will be circulating to every household in the next month or two, which we really want you all to fill in. The more information we get, the more views we have, the better will we be able to plan for the future.

If you belong to an organisation in the village and want to know how the Plan will affect your group or how you can influence the Plan, please get in touch as someone from the Steering Group will be only too happy to come and talk to your group. Please contact Sheila who is looking after all admin matters.

Finally, look out for anything with the magic words Neighbourhood Plan on them. Remember it is your opportunity to shape the future of our amazing village.

Rother District Council:

TREES, HEDGES & HIGHWAYS

Overgrown trees, hedges and vegetation can cause problems for people using highways and footpaths, especially if they suffer from impaired vision or need a little more space for wheelchairs, mobility scooters or buggies.

A tree is the responsibility of whoever *controls the land* on which the tree is growing - occasionally this is an agent or tenant. That person has a legal responsibility to ensure their tree(s) cause no harm to highways users. If overhanging a road, there must be at least least 5.2 m clearance above the road, or 2.4 m for a footpath.

The Highways Authority can (under The Highways Act 1980) serve you a notice giving you 14 days in which to cut back vegetation causing a nuisance, and if this is ignored, they have the right to deal with it and reclaim the cost from you! No-one wants it to come to this, so please keep on top of maintaining *any* vegetation (including hedges and shrubs) at the edges of your property.

If a tree is protected by a Tree Preservation Order (TPO) or growing in a Conservation Area, you must consult Rother District Council before cutting it back.
